

READY RECKONER OF OFFENCES AFFECTING THE PUBLIC HEALTH, SAFETY, CONVENIENCE, DECENCY AND MORALS

Under the BNS Act Offences Affecting Public Health, Safety, Convenience, Decency and Morals have been defined under Chapter- XV from Sections 270 to 285 with amendments of the quantum of punishments or addition of new words in the existing IPC provisions (fine or Imprisonment).

273. (Section 271) Disobedience to quarantine rule

The distinction between Section 273 of Bharatiya Nyaya Sanhita (BNS) and Section 271 of the Indian Penal Code (IPC) lies in the terminological modification introduced by the new legislation. Specifically, the contemporary legal framework substitutes the term "(vessels)" with the more encompassing phrase "mode of transport" in BNS.

274. (Section 272) Adulteration of food or drink intended for sale

Fine enhanced from one thousand to five thousand rupees. The rest of the content are same as of IPC.

275.(Section 273) Sale of noxious food or drink

Fine enhanced from one thousand to five thousand rupees. The rest of the content are same as of IPC.

276.(Section 274) Adulteration of drugs

In Sections 276, BNS the duration of imprisonment is increased to 1 year instead of 6 months as in 274 IPC.

277. (Section 275) Sale of Adulterated Drugs Fine under enhanced from one thousand to five thousand rupees. Classification of Offence: Cognizable Non-bailable Triable Court of Session Nonby compoundable 278. (Section 276) Sale of drug as a different drug or preparation Fine enhanced from one thousand to five thousand rupees. Classification of Offence: Cognizable Non-bailable Triable by Court of Session Noncompoundable 279. (Section 277) Fouling water of public spring or reservoir In Sections 279, BNS it is increased to 6 months instead of 3 months as in 277 IPC Classification of Offence: Cognizable Triable Non-bailable by Court of Session Noncompoundable. 280.(Section 278) making the atmosphere noxious to health Classification of Offence: Fine enhanced from five hundred to one thousand rupees. Cognizable Non-bailable Triable by Court of Session Noncompoundable 282.(Section 280) Rash navigation of vessel Fine enhanced from one thousand to ten thousand rupees. **Classification of Offence:** Cognizable Non-bailable Triable Court of Session Noncompoundable

283.(Section 281) Exhibition of false light, mark or buoy

Fine shall not be less than ten thousand rupees.

284. (Section 282) conveying person by water for hire in unsafe or overloaded vessel

Fine enhanced from one thousand to five thousand rupees.

285.(Section 283) Danger or obstruction in public way or line of navigation Fine enhanced from two hundred to five thousand rupees.
