

# About BPR&D

## **EVOLUTION**

BPR&D was set up as an attached office of the Ministry of Home Affairs on 28th August, 1970. The objectives for setting up of the Bureau were:

- To undertake studies on Police problems;
- To promote application of science and technology in Police work;
- To review the resources for Police training and formulating and coordinating training policies and programmes;
- To advise the Ministry of Home Affairs on technical aspects of police work and operational matters;
- To promote the development of Forensic Science in the country;
- To organize national level conferences on various issues pertaining to Policing and Prisons for States/ UTs/CAPFs/CPOs.
- To enter into MsoU with Academia, research institutes, technical laboratories, and R&D organizations, for collaboration.

## ORGANIZATION

The Bureau is headed by an Indian Police Service Officer of the rank of Director General, who is assisted by the Additional Director General. There are 6 divisions working under the supervision of Inspector General rank officers:-

- Research and Correctional Administration.
- Training. •

National Police Mission.

- Administration
- Modernization and Technology Development. Special Police Division

## TRAINING INSTITUTIONS- CENTERS OF EXCELLENCE

In order to discharge its overarching madate BPR&D has set up a number of institutions to address wide ranging needs of research on relevant issues and training of police personnel from all states and CAPFs. The institutions currently running under BPR&Ds purview are:

- Central Academy for Police Training (CAPT) Bhopal (2011) – For basic training of directly recruited DySsP of states and UTs, Centers of Excellence for Traffic Technologies, Prosecution, and Correctional Administration.
- Central Detective Training Institute, Kolkata (1956) - Centre of Excellence for Community Policing, Investigation of Crimes against Women and Children and Human Trafficing.

- . Central Detective Training Institute, Hyderabad (1965) - Centre of Excellence for Police Information Technology and Investigation of Cyber Crimes.
- . Central Detective Training Institute. Chandigarh (1970) - Centre of Excellence for Investigation of Organized Crimes.
- Central Detective Training Institute, Ghaziabad (2012) - Centre of Excellence for Counter-Terrorism and Counter-Insurgency.
- Central Detective Training Institute, Jaipur (2012) - Centre of Excellence for Investigation of New Age Crimes.















# Research Wing

The Research Division of BPR&D came into existence with the establishment of the Bureau of Police Research and Development on 28.08.1970. The Division's mandate to identify the needs, problems of the police service in the country and initiate, stimulate and guide research in this field, in coordination with various Institutions, Ministries, Universities, Research Institutes, Director General of Police of States and other agencies and individuals interested in the subject.

To fulfill its mandate the Research Division has completed 286 research studies on police subjects, criminal justice system and correctional administration. These topics have been identified organizations and collaboration with reputed organizations and institutions dealing in research activities and States/UTs/CPOs/CAPFs/State Police and other stakeholders. Much of this research is "action-oriented" and their reports and recommendations are disseminated to all stakeholders for appropriate use.

In pusuance of its objectives, the Research Division:

- Grants 12 fellowships annually in order to encourage advanced research and studies in criminology and police science at the national level and to foster young talent, A total of 82 fellowship thesis has been completed so far.
- Has published a National Police Research Repository comprising of all the completed research studies and fellowship thesis from 1970 to 2016.
- Has drafted the first National Witness Protection Scheme, 2018 in collaboration with National Legal Services Authorities (NALSA). The scheme has been approved by the Hon'ble Supreme Court of India for implementation.
- Has submitted a concept note on National Registry of Sexual Offenders to the MHA for

ensuring that law enforcement authorities have a readily available database of sex offenders and keep track of them if necessary.

- Has submitted the concept note on National Highway Safety Services to the NHAI and MHA. The objective of the NHSS is to provide legal, institutional & financial framework for road safety.
- Has entered into an MoU with Police Foundation and Institute, India to establish the framework of collaboration and working relationship to launch a 'Scheme of Standardization and accreditation – with the ultimate purpose of a step-by-step raising of the quality standards of police governance and police service delivery'.
- Has entered into an an MOU with TISS, Mumbai and NLU, Jodhpur for greater collaboration in Research, Conference and Training related to Policing and Correctional Administration issues.
- Has awarded the first All India Citizens Survey of Police Services (AICSPS) to the National Council of Applied Economic Research (NCAER), New Delhi. The objective of the AICSPS is to supplement existing data on crime incidence, recording and to obtain data on safety perceptions and attitudes towards the police from the sample size of more than 1.2 lakh households.

In addition, the Research Division

- Organizes the All India Police Science Congress (AIPSC), annually, to address the latest Policing issues.
- Coordinates the BPR&D's Internship Programme since 2017. Total 70 internships have been completed so far.

# **Correctional Administration Wing**

Ministry of Home Affairs, Government of India, identified BPR&D as the nodal agency, at the national level, in the field of Correctional Administration and Prison Reforms. The Correctional Administration (CA) Wing was set up in November, 1995, to identify and study the problems affecting prison administration and to promote advanced research and training in this field.

The CA wing is responsible to initiate and guide research in Prison matters both in-house and in collaboration with reputed organizations having expertise in the area of professional interest, after identifying the issues involved. It is the repository of information, statistics and details which affect the core prison functions in a seminal manner.

The CA Wing conducts conferences and seminars at the national level on numerous issues concerning Correctional Administration and Prison Reforms. It also organizes the All India Conference of Heads of Prisons, National Conference on Uniformed Women in Prison Administration and All India Prison Duty Meet. It undertakes capacity-building efforts and sponsors training programmes for prison officers and releases publications on prison related issues. 517 prison training courses have been conducted and approximately 11,448 prison officers have been trained since 1997.

Coordinating the awarding of President's Correctional Services Medal for Distinguished Services/Gallantry and Correctional Service medal for Meritorious Service/Gallantry for prison personnel of all ranks is another responsibility of the Wing. Since January, 2000, 25 CS medals for Distinguished Services and 75 CS medals for Meritorious Services have been awarded to the prison officers of all ranks for their dedicated services.

The Division has published the Handbook on Responsibilities & Obligations of Prison Officials, Model Prison Manual 92003, for the Superintendence and Management of Prisons in India, National Policy on Prison Reforms and



The BPR&D distributed 11130 Sexual Assault Evidence Collection Kits (SAECK) procured by DFSS upto level of SDPO in all the States/UTs.

## FOREIGN COURSES

**Development Specialist Investigators Scheme (DSI)** - During the year 2019-20, 02 advanced training programmes were conducted at PTC, Singapore under Development Specialist Investigators Scheme (DSI) in which 43 Indian Police Officers have been trained.

Anti-Terrorism Assistance (ATA): During the year, 14 Anti-Terrorism Assistance (ATA) courses were offered by US Embassy, New Delhi. Out of 14 courses, 13 ATA courses have been conducted at CAPT, Bhopal and CDTI, Ghaziabad in which 209 Police Officers have been trained. The 14th course had to be cancelled due to spread of Corona Virus in March 2020.

**Courses for SAARC and other Countries:** 76 training courses were coordinated by BPR&D in which 1346 Police personnel of SAARC and foreign friendly countries had undergone various training programmes in Indian Police training institutions.

**Training course on 'Community Policing'** was organized for 10 Afghan National Police Officers at CDTI, Ghaziabad in February, 2020 in collaboration with Ministry of External Affairs.

## 4.7 TRIAL DIRECTIVES AND QRS FINALIZED.

**4.7.1** The BPR&D constituted a sub-Group Committee comprising officers / experts from BIS, NITRA, DGQA, TBRL Chandigarh and CAPFs. 



Govind Vallabh Pant Puraskar Yojna With the aim of promoting and encouraging the writing of books in Hindi, the BPR&D annually felicitates 9 writers, who publish their books in Hindi (on subjects like Policing, Criminal Justice System, Criminology, Forensic Science and Prisons) or translate books from any other language into Hindi.
- DoPO The Bureau of Police Research and Development has been publishing Data on Police Organizations annually since 1986. 



he first Central Detective Training Institute, was set up at Chandigarh in 1973. There are now five CDTI in India located at Chandigarh, Hyderabad, Kolkata Jaipur and Ghaziabad functioning under Bureau of Police Research & Development, Ministry of Home Affairs.

The objective of the CDTIs is to provide training to inservice police personnel upto the rank of Dy. Ss.P. Among the several courses run by the institution, the course of the longest duration (10 weeks) is Advanced Cource on Investigation & Detection of Crimes for the police personnel of the rank of Sub Inspectors and Inspectors having minimum 5 years experience in their respective fields. In this course the police personnel are trained on various aspects of Scientific Aids to Investigation as well as Law & Procedure and professional knowledge. The syllabus of the course is chalked out by BRP&D and is upgraded regularly to make it more relevant and topical. The purpose of imparting the aforesaid training is to prepare investigators for acquiring latest knowledge and awareness of scientific techniques of investigation and latest developments in the Forensic fields. It is the constant endeavor of CDTIs to continuously improve upon the course contents and make the training course interesting and trainee friendly. The Officers drawn from Northern Parts of the country and abroad (SAARC) countries attend various courses at CDTI, Chandigarh.



## ABOUT BPR&D







The Central Detective Training Institute, Ghaziabad was setup on the recommendations of Gore committee on Police Training (1970) after 03 other similar training institute viz Kolkata, Hyderabad and Chandigarh and started functioning on 16th January, 2012 under the aegis of Bureau of Police Research and Development, with an objective to provide in-service training to Police Officers to improve the standards of crime investigation in India by familiarizing the Police Officers with various development in froensic

sciences. CDTI, Ghaziabad with asprawling 8.37 Acre caters to the need of Police Officers from Northern and Central regions of India viz MP, UP, Delhi, Bihar, Uttrakhand, Jharkhand, Chhattisgarh and various Central Police originations/ agencies. Aiming to train 1250 Police Officers each year it has trained total 6680 (including 84 foreigners) police officers since its inception. It has also hosted 14 ATA courses (sponsored by US Embassy) in which total 252 police officers participated.

### MANDATE

The mandate of CDTI, Ghaziabad is to provide training to in-service personnel of the rank of SI to Addl. SP to enhance their investigative skills by imparting latest knowledge of scientific techniques and best practices in investigation and awareness

of latest developments in forensic science. CDTI, Ghaziabad has been declared as Centre for Excellence of "Counter Terrorism, Counter Insurgency and related issues".





## **NEW INITIATIVES**

- During the year, the Academy has received its two ISO certificates for capacity building of police officers, prosecution officers, prison officers and drug law enforcers. The academy has been assessed and found to be in compliance with the requirement of the standard ISO 90001: 2015 certification in Quality Management System and ISO 14001: 2015 for Environment Management System.
- The officials of the CAPT have self adopted mandate for cleaning the surroundings for a hygienic community. The magical 3R's- Reduce, Reuse and Recycle is followed everywhere in the CAPT. Organic waste generated from the residential areas and hostels are dried and decomposed in composite pits. Controlling the use of plastic bags has also help us to keep the Academy clean.
- In the month of January 2020, A shopping complex building was made functional to cater for the daily provisions of the families and trainees coming for various training events from across the country and abroad. A food

court and SBI ATM has also been established in the shopping complex.

- On 13th June 2019, Shri Sudeep Lakhtakia, IPS, DG BPR&D inaugurated a children's park in the


Academy. He also inaugurated Gymnasium and Lawn Tennis court in the sport complex on the same day.
