### Workshop on India Suicide Bomber:



meeting of Registrars/Reps. of Universities was held at BPR&D headquarters, New Delhi on 22<sup>nd</sup> February, 2008, to finalize the uniform parameters for undertaking research studies on, "State of Affairs of Police Families". Registrar, Nodal or Liaison Officers and academicians from various Universities participated in the meeting. The meeting was chaired by Shri R.C. A three members Committee comprising Prof. Vimala Veeraraghavan, Amity Institute of Behaviour Health, Amity University, NOIDA(UP), Dr. R. Thialagraj, Head of Criminology Deptt., University of Madras, Dr. G. Karunanidhi, Head of Sociology Deptt. presented the parameters shortlisted for the proposed research study. The same were discussed threadbare

and many a useful suggestions were proposed. Now the group is to finalize these parameters for being used in the proposed study. It was also proposed that Universities willing to set up a Chair for undertaking research studies on Police and Prison Administration related issues, should prepare a detailed proposal for approval by the UGC.

A team from Indian Institute of Technology (IIT) Delhi, made a presentation about outlines of a research project to design a new uniform for police personnel at BPR&D headquarters on 7th February. The meeting was held in the presence of the members of the committee constituted by the MHA for revision of uniform (PET) items for the CPFs personnel. All parameters for

designing of a good uniform like fiber (natural, synthetic, blends), weight, color of cloth, application of uniform in different climatic conditions etc. were discussed in order to prepare a self contained fresh proposal for consideration by the Standing Committee.
